“TO SNITCH OR NOT TO SNITCH: WHEN KEEPING IT REAL GOES BAD”

“IS THE DRUG WAR THE NEW JIM CROW?”

We must understand the connections between the policies of the past and those of the present. Segregation was outlawed in the 1960's. Was it replaced by the drug war? National drug policy is not only racist, but an abject failure. Black imprisonment for drug offenses is 13 times that of the rate for Whites, despite equivalent rates of drug use. Just as policies of yesterday's Jim Crow era were harmful, the adverse impacts of today's drug policies on employment, housing, education, families, health care and the franchise are also damaging. This session will address these issues and identify practical ways to ameliorate the harm.

**“HEALTH CARE IS A HUMAN RIGHT: WHAT PASSAGE
OF HR 676 MEANS TO BLACK PEOPLE”**

Panelists will analyze health care as a human right under international law and the challenge of urging passage of HR 676, a congressional bill sponsored by U.S. Rep. John Conyers that would create a national single-payer health care system in the U.S. that is based on the principle that health care is a human right.
